To authorize other Customs brokers to act as grantor's agent; to receive; endorse and collect checks issued for Customs duty refunds in grantor's name drawn on the Treasurer of the United States; if the grantor is a nonresident of the United States, to accept service of process on behalf of the grantor; and generally to transact at the customhouses in any district any and all Custom business, including making, signing, and filing of protests under section 514 of the Tariff Act of 1930, in which said grantor is or may be concerned or interested and which may properly be transacted or performed by an agent and attorney, giving to said agent and attorney full power and authority to do anything whatever ratifying and confirming all that the said agent and attorney shall lawfully do by virtue of these presents, and to hold harmless for any untimely and/or inaccurate filings; the foregoing power of attorney to remain in full force and effect until notice of revocation in writing is duly given to and received by a District Director of Customs. If the donor of this power of attorney is a partnership the said power shall in no case have any force or effect after the expiration of two years from the date of its execution. If the grantor is a limited liability company, the signatory certifies that he/she has full authority to execute this power on behalf of the grantor. If you are the importer of record, payment to the broker will not relieve you of liability for Customs charges (duties, taxes, or other debts owed Customs) in the event the charges are not paid by the broker. Therefore, if you pay by check, Customs charges may be paid with a separate check payable to "U.S. Customs Service" which shall be delivered to Customs by the broker.
